### Order under Section 144 of code of criminal Procedure, 1973.

Whereas, an Order No. 40-3/2020-DM-I(A) dated 29.06.2020 by the National Disaster Management Authority was issued for containment of COVID-19 in the country for a period upto 31.07.2020 and order no DMC-SPO-2020/7563 dated 30.06.2020 by Chief Secretary-cum-Chairperson Haryana State Executive Committee was issued for containment of COVID-19 in the state for a period upto 31.07.2020;

Whereas, in exercise of the powers under section 6(2)(i) of the Disaster Management Act, 2005, National Disaster Management Authority (NDMA) has directed the Chairperson, NEC to issue an order to re-open more activities, in areas outside the Containment Zones and to extend the lockdown in Containment Zones upto 31.08.2020;

Pursuant thereto, the NEC vide letter dated 29.07.2020 while exercising the powers under section 10(2)(i) of the Disaster Management Act, 2005, issued guidelines on Unlock 3, (as **Annexed**) to remain in force upto 31.08.2020 within the territory of India.

Therefore, now under the directions of the aforesaid orders of NDMA dated 29.07.2020 and the Guidelines for Phased Re-opening (Unlock 3), issued by NEC on dated 29.07.2020 under the Disaster Management Act, 2005, the Chief Secretary-cum-Chairperson Haryana State Executive Committee in her capacity as Chairperson, State Executive Committee has directed that guidelines thus issued, will remain in force upto 31.08.2020 within the territory of State of Haryana. Guidelines issued by NEC on Phased Re-opening (Unlock 3), are annexed herewith for strict implementation.

Whereas the lockdown in Containment Zones has been extended for 31 days till 31<sup>st</sup> August, 2020, therefore, steps need to be taken for its enforcement. Therefore, I, Yashpal, IAS, District Magistrate, Faridabad do in exercise of power vested in me by virtue of section 144 of Code of Criminal Procedure, **do hereby order that all the activities in the containment zones shall be prohibited except essential and emergency services and lockdown shall be continue to remain in force in the containment zones till 31.08.2020** in the district Faridabad. Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years, shall stay at home, except for meeting essential requirements for health purposes.

**Shops and commercial establishments across the district are allowed to remain open on all days except Tuesdays. They will remain closed on Tuesdays.** The order no 1402-28/PA and 2784/MB-3 issued on dated 06.07.2020 (**Annexure-A**) and dated 13.07.2020 (**Annexure-B**) will also remain applicable regarding opening of shops. They shall strictly abide by the SOPs as stated.

All the religious institutions shall also open and strictly follow the SOP issued by Govt. of India and Govt. of Haryana. The management of these institutions shall ensure that SOPs are followed.

This order shall come into force with immediate effect and shall remain in force till 31.08.2020 if not revoked earlier.
